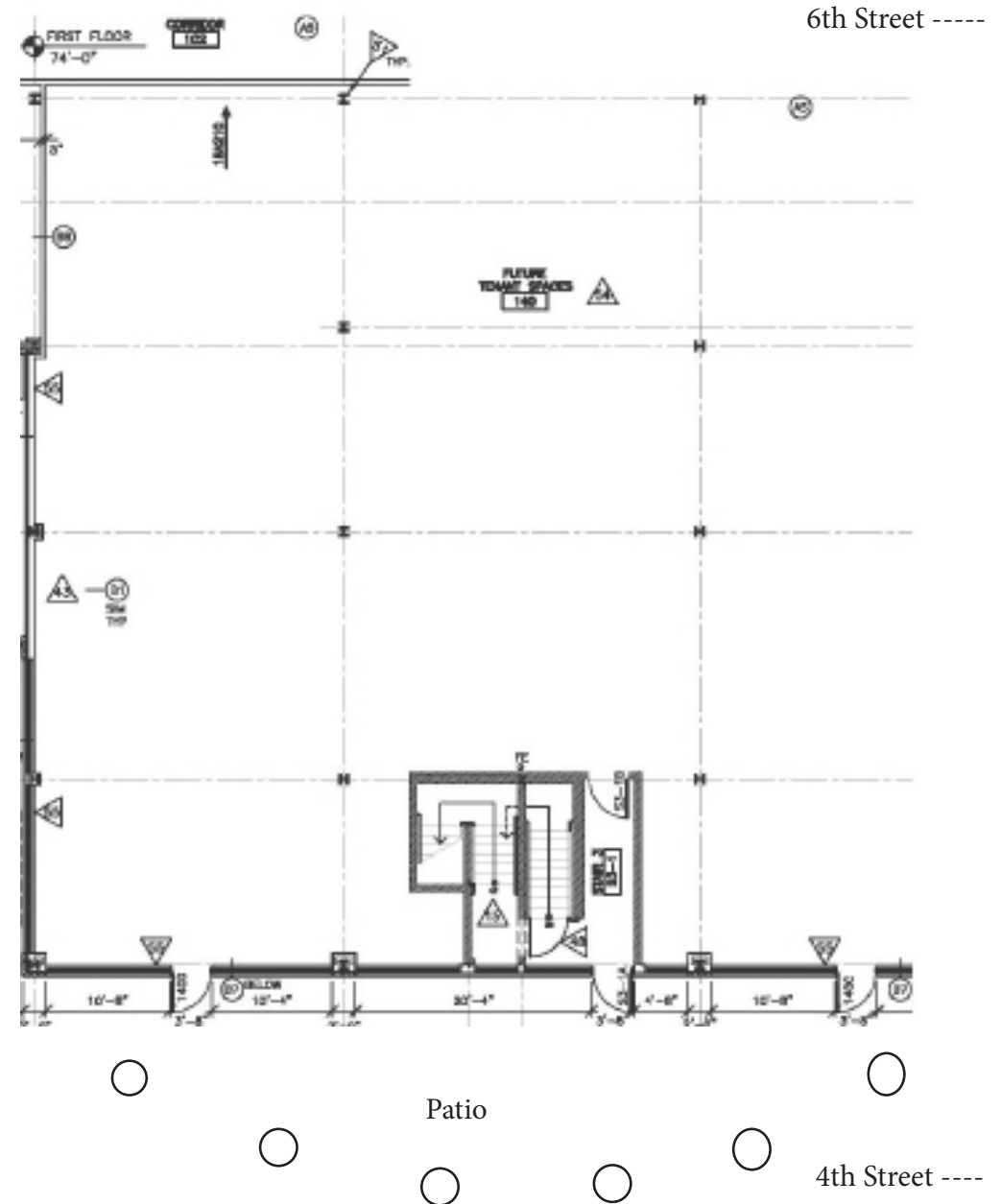

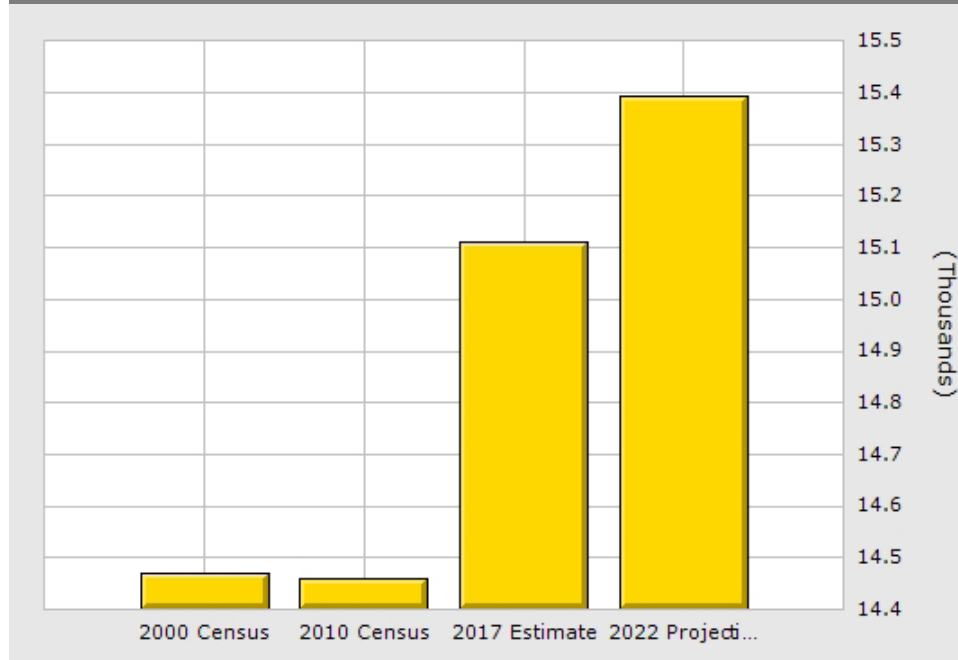

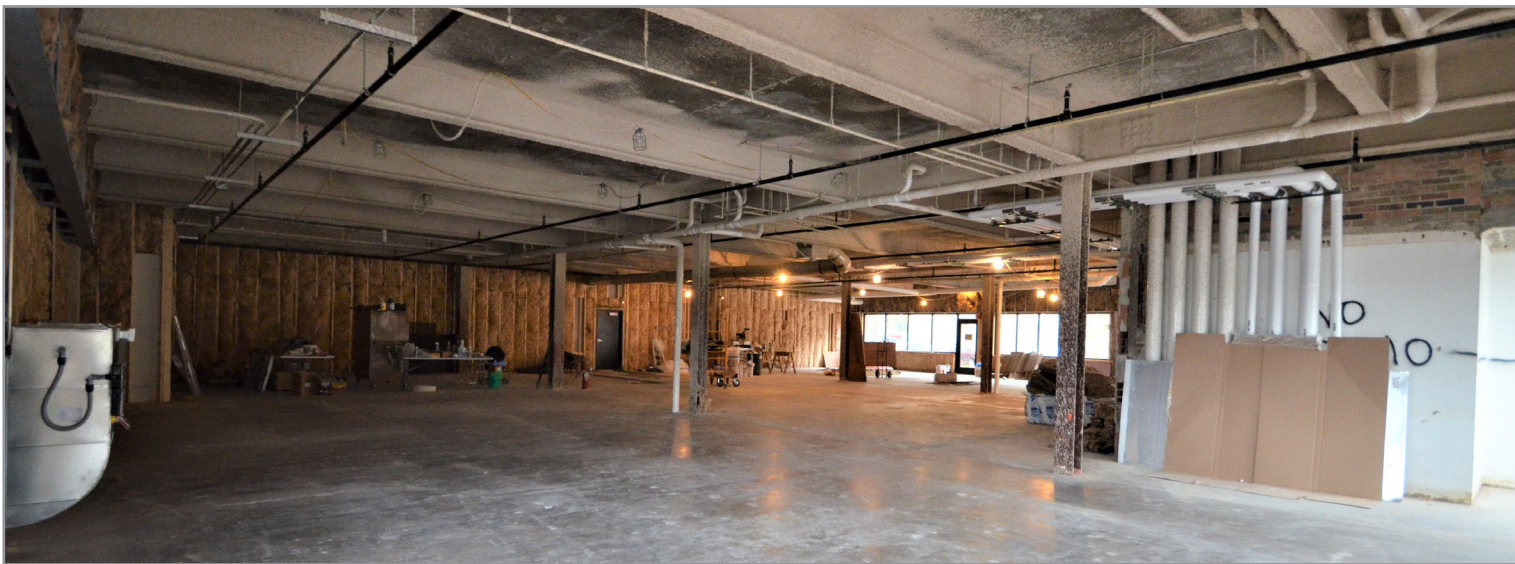
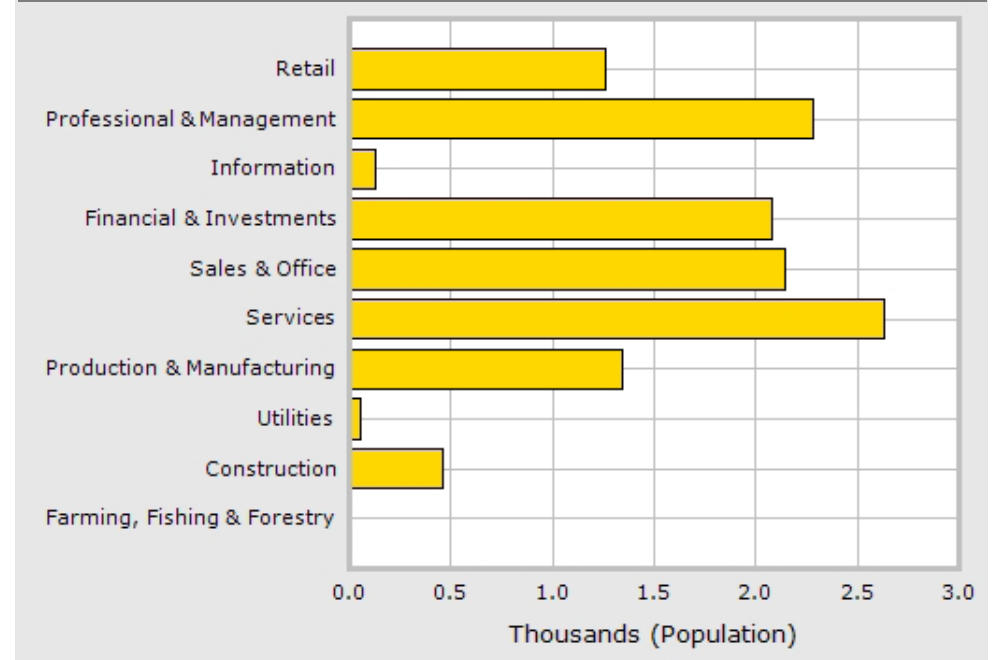


NEIGHBORHOOD DEMOGRAPHICS

POPULATION PROJECTION

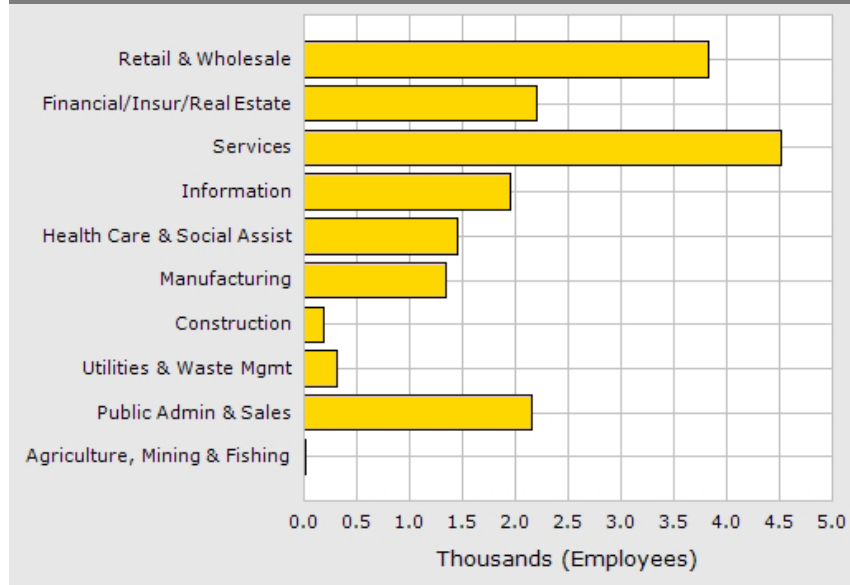


CIVILIANS AND THEIR OCCUPATIONS

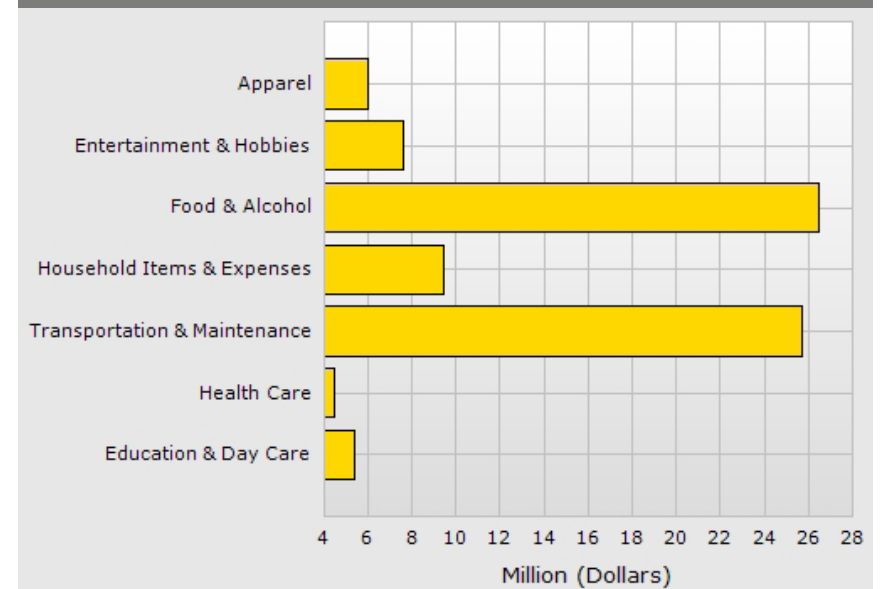


POTENTIAL CUSTOMERS & SPENDING
