Q. Is Gateway Northeast Section 8 housing?

A.No, Gateway Northeast is fantastic mix of market rate and Section 42 housing. Rent is based on a fixed rental fee for the unit size that is lower than the average market rate rent in the area. Applicants must have a source of income to pay rent. Section 8 Voucher holders are encouraged to apply. (Rent is not 30% of income)

O. Is there an application fee?

A.Yes, the application fee is \$35.00 for each household pacious 1 and 2 bedroom members age 18 and over.

Q. How much is the security deposit?

A.The security deposit is \$500.00.

Q. What utilities do residents pay?

A.Residents will pay for electric, gas, phone, internet Siled Access Entry cable.

O. What type of parking is available?

A.Off-street covered and underground parking is Underground Parking available.

O. Do you run background checks?

A.Yes, rental and criminal reports are run on all prospective residents age 18 and over.


