



## City of Fayetteville, Arkansas Rental Fee Disclosure Form Greens at Fayetteville, a Limited Partnership

In compliance with City of Fayetteville Ordinance 6883, this City of Fayetteville, Arkansas Rental Fee Disclosure Form ("Disclosure Form") serves as the required notice to a potential tenant that the landlord or property owner has disclosed fees and utility responsibilities associated with the proposed Apartment Lease Contract for an apartment unit with these specific rental options located within the premises of the apartment community listed below.

This Disclosure Form shall be incorporated as part of the Apartment Lease Contract when signed by the tenant/resident.

### **AMOUNTS OWED PRIOR TO LEASE SIGNING**

Application/Screening Fee: \$40.00, Nonrefundable.

Application Deposit: \$350.00; Refundable if applicant is denied after screening; Nonrefundable if applicant is approved but credited toward the security deposit at lease signing.

Security Deposit: \$350.00; Refundable at the end of the lease term if tenant gives 30 days' written notice of lease termination. This refundable deposit will be applied first to any lawful deductions, then any credit balance will be refunded in accordance with Arkansas law.

Conditional Security Deposit: \$375.00; This deposit is available as an alternative to obtaining a guarantor, if needed. Refundable at the end of the lease term after application to any lawful deductions, then any credit balance will be refunded in accordance with Arkansas law.

Pet Deposit: \$300.00; Nonrefundable

Waterbed Deposit: \$50.00

### **POTENTIAL FEES**

Late Fees: \$10.00 per day after a 3 day grace period

Returned Check/Returned Payment Fees: \$30.00

Disputed Credit Card Transaction Fee: \$50.00

Unauthorized Pet Fee \$50.00 for the first day and \$10.00 for each additional day the unauthorized pet remains on the premises

Re-Key Lock or Duplicate Key: One Door \$25.00; Two Doors \$50.00 Mailbox Key \$25.00

After hours and on Weekends Open Door Fee: \$25.00

Access Card Replacement or Failure to Return Access Card: \$25.00

### **UTILITY RESPONSIBILITIES**
